Non-degree Seeking Students: Students who are in the admission process or wish to enroll in courses for enrichment or certification may register as non-degree students under the following conditions: Undergraduate students may enroll for one semester only, 15 credits maximum. Graduate students may enroll for a maximum of 12 credits. Non-degree applications are available online at http://www.fiu.edu/orgs/register/Non_Degree_Form_Web.pdf. Credit hours are earned but there is a limit on how many classes may be applied towards a degree as a non-degree student.

Health Fee: \$67.20 - This fee is **not** collected if you are taking **all** of your classes in Broward. Students may pay fee and use the Student Health Centers on Biscayne Bay or University Park Campus.

Parking Access Fee: \$82.39 – This fee is charged to all students

Athletic: \$10.00 - This fee is charged to all students.

Photo ID Cards: \$10.00 - Yearly Fee. Photo ID cards will be produced for new students within the first two weeks of the semester. **Please check at the Registration Offices for the dates. Note: Your FIU ID is required for access to most library resources.**

Late Registration: Students who register after the posted registration deadline will be subject to \$100 late registration fee.

Late Payment: Students who pay fees after the payment deadline will be subject to a \$100 late payment fee. If applicable, this fee may be assessed in addition to the late registration fee. Students will be dropped for non-payment.

Fee Payment Options (Last day to pay for Spring 2010 is January 8th)

- ☞ **Option 1** – Payment may be made online by E-check or credit card. **Note:** acceptable cards are American Express, MasterCard, or Discover Cards. There will be a 2% non-refundable credit card surcharge charged to the credit card.
- ☞ **Option 2** – Payment may be placed in the Cashiers Drop Box before 5:00 p.m. on last day to pay at the Pines Center.
- ☞ **Option 3** – Payment may be mailed* & must be received by last day to pay.
- ☞ **Option 4** – Payment may be paid in person at the Cashiers Office (Modesto A. Maidique Campus or Biscayne Bay Campus) by 5:00pm p.m.

*Make checks payable to **Florida International University**. Your **Panther ID**, address, and phone number must appear **on the check**. **Cash payments are accepted only at the Cashier's Office at Biscayne Bay or Modesto A. Maidique**

Immunizations

The State of Florida requires state university students to provide immunization documents **before** they may register for the first time or after an interruption of studies. If you were born **after** January 1, 1957 you are required to show proof of immunity to Measles (Rubeola) and Rubella (German measles). All students must show proof of immunity to Hepatitis B and Meningitis before you will be able to register for classes. Residency Requirements

To establish Florida residency for tuition purposes, students or their parents/guardians if students are dependent, must have resided and had their domicile in the State of Florida for at least twelve consecutive months immediately preceding the first day of classes of the current term. **Two** of the following proofs are required to establish official Florida residency: Drivers License, Voter's Registration, and Vehicle Registration. Non-degree students must either be a US citizen or have an Alien Registration ID as well as the required residency documents.
